5.3 Advice for firefighters

SECTION 7: Handling and storage

7.1 Precautions for safe handling

Vapours are heavier than air and may spread along floors. Vapours may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapours in air and avoid vapour concentrations higher than the occupational exposure limits. In addition, the product should be used only in areas from which all naked lights and other sources of ignition have been excluded. 8.2 Exposure controls
